On March 6, 2025, INNOVATE Corp. (NYSE: VATE), as the borrower, and INNOVATE 2 Corp. and DBM Global Intermediate Holdco Inc., subsidiaries of the issuer as guarantors, entered into a Sixth Amendment (the "Amendment") to the issuer's Credit Agreement, dated March 13, 2020, with MSD PCOF Partners IX, LLC, as lender, which governs the Borrower's senior secured revolving credit facility (the "Revolving Credit Facility"). The Amendment extends the maturity date of the Revolving Credit Facility to August 1, 2025.
